ORDER:-

During the state development board meeting held on 13-9-96, among other thing, it was observed that the beneficiaries should be encouraged to take up the works at the estimated cost or even at marginally higher cost, with the idea of eliminating intermediaries like the contractors.

2. The matter was placed before the board of C.Es. The Board of CEs after discussions, made certain recommendations to the beneficiaries in respect of all works in irrigation and command area development department.

I)a. Works unskilled nature costing Rs. 50,000/- and less may be allotted to the beneficiaries.

b. These works may be entrusted on nomination at Govt. rates.

II)a. Payment of EMD at the time of entering into contract may be exempted.

b. Security deposit at the prescribed rates has, however, to be withheld from bills payable.

III). Beneficiary is to be nominated by the MRO with supporting proof within a fortnight from the date of receipt of requisition from the department concerned. If such nomination is not received within the time, the executing department may take up the work as per rules laid down for the entrustment and execution of such work.
