ORDER:

In the circumstances reported by the Engineer-in-Chief (R&B) Administration & NH his letter 5th read above, Government after careful examination of the matter, hereby issue the following, clarifications for implementation of the G.Os 2nd, 3rd and 6th read above.

- i. Price adjustment shall be applicable within the original contract period or period extended on grounds of departmental delays and shall not be applicable to extensions granted on account of contractors fault, as envisaged in G.O. 1st read above.
 - ii. Price adjustment shall be applicable from the date of agreement, for all those ongoing works, where final bills are not taken by the contractor as on the date of issue of G.O. Ms. No. 73, dt. 24-4-2006.
 - iii. Price adjustment shall be applicable for the actual components/items of works actually carried out during the period of the bill.
 - iv. The above orders are applicable for all works R&B Department i.e., Roads, Bridges and Buildings works.
 - v. Price adjustment shall be applicable for Other Materials in respect of Road and Bridge works and applicable for all Building works as per the G.O. 6th read above.
2. The Engineer-in-Chief (R&B) Administration & Roads shall take necessary action accordingly.
 3. This order issues with the concurrence of the Finance Department vide their U.O. No. 35125/1000/A2/Expr.PWD/06, dt. 19-2-2007.
