Anent to the reference cited, it is to inform that the copy of G.O. Ms. No.226 MA, dt.17-6-2004 has been furnished to you vide this office Lr. No.104/QC/T5/2005, dt.23-2-2006. A decision has been taken in the minutes of meeting held on 15-12-2003 in the chambers of Principal Secretary to Government, Finance (Works & Projects) Department that in respect of PH the Quality Control Certificate need not be insisted for the present.

Further it is to inform that efforts for improving Quality Control Systems are being made to obtain and finalize the procedures and standards as per BIS, MORTH and in consonance with sister departments for finalizing a Quality Control Manual. The Divisions are yet to be equipped with necessary Quality Control equipment and vehicles etc., to have proper inspection. Further the staff working with Q.C.D. are being deputed to acquire up to date knowledge with the institutions like NAC etc.

Soon after the finalization of QCM and other paraphernalia the same will be communicated for implementation. Till such time the instructions contained in the Minutes of the meeting held on 15-2-2003 in the chambers of Principal Secretary to Govt., Finance (W&P) Department will hold good in case of this department unless otherwise orders contrary to the above is given either by ENC (PH) or MA & UD Department.

In view of this you are requested to allow the work bills of PH Department without Q.C. Certificate until a decision is taken and communicated from this office.
