## ORDER:

- 1. In the G.O.1st read above, orders were issued permitting the Executive Engineers to conclude supplemental agreements with the contractors for works under execution and to be entrusted in future basing on the request of Builders' Association of India to deduct 0.25% of gross amount of bill and remit it to the Institute of Construction Technology of India, at Hyderabad by 5th of every succeeding month .
- 2. In the G.O.2nd read above, orders were issued that all the Departments of the State as well as the Corporations under their administrative control include the condition of contribution of 0.25% from the Contractors gross bills, as their contribution to the National academy of Construction by including it as condition in the Tender Documents and Agreement Forms, thus making such contribution mandatory.
- 3 In the G.O.3rd read above, it was amended to divide the 0.25% contribution between Chief Minister's Relief Fund and National Academy of Construction in the ratio of 0.15% and 0.10% respectively.
- 4. The Director General, National Academy of Construction, Hyd, in his Ir.4th read above, has informed that the activities of NAC, have increased manifold and there is a clear direction from the Government to increase the number of persons to be trained in construction trades from 3,000 to 30,000. and need additional resources to match the expenditures. During the Governing Board meeting of the NAC held on 27th November, 2006, it has been decided to restore the contribution to National Academy of Construction to 0.25% from the Gross Bill of Contractors to the NAC.
- 5. The Government after careful examination of the matter, hereby issued orders to restore the contribution to 0.25% from the Gross Bill of Contractors to the National Academy of Construction, by withdrawing 0.15% contribution to C.M's Relief Fund as ordered in the G.O.3rd read above.
- 6. The Director General, National Academy of Construction, Hyderabad, shall take action accordingly.

7. This order does not require the concurrence of Fin (Expr.PW) Department.
