## ORDER:

The Chief Engineer, G.L.I.S., K.C.Camp, Warangal has informed that Technical sanction for the estimate "Forming embankment from Km.332.000 to Km.333.000 including structures on Kakatiya Main canal" was accorded as per SSR 2002-2003 in CER.No.79/2003-04, dated:2.12.2003 for Rs.115.00 lakhs.

- 2. Controlled blasting is not contemplated while sanctioning the estimate, as no houses were existing adjoining the alignment at the time of estimate. But, houses have been built subsequently during the progress of the work necessitating controlled blasting due to safety regulations.
- 3. The work of "Earth work excavation and forming embankment from Km.332.00 to Km.333.00 including construction of structures on Kakatiya Main Canal" is partly executed leaving balance of Hard rock excavation, which requires controlled blasting. The Chief Engineer, G.L.I.S. has reported that out of the total quantity of 24,324 cum of Hard rock, the contractor has executed 3,297 cum leaving a balance quantity of 21,027 cum. Since the canal is passing by the habitations, where some houses are existing, the Hard rock excavation requires controlled blasting as per safety regulations.
- 4. The Chief Engineer, G.L.I.S. has reported that, the rate as per the agreement is Rs.232/- per cum, and including conveyance for ½ Km. the rate would be Rs.281/- per cum.
- 5. The Contractor stopped the work and on persuation, the Contractor agreed to continue the work, either to allow his agreement rate with controlled blasting of Hard rock or as per the current SSR rate without tender discount.
- 6. In order to overcome the bottleneck and complete the work, the Chief Engineer, G.L.I.S. has submitted a proposal for payment of balance work with current SSR rates of H.R. without applying tender discount and to allow H.R. rates as per agreement for the quantities already executed, since the Contractor agreed to complete the work with the above proposal.

- The Chief Engineer, G.L.I.S., Warangal shall take necessary action accordingly.
