**Sub:-**(R&B) Department –Works – Wet Mix Macadam item of work-Use of Mechanical Paver Finisher-Violation of Government instructions and MORT&H specifications by Filed Engineers-Certain instructions-Issued-Regarding.

- 1. Government Circular instructions were issued vide reference  $1^{st}$  cited stipulating mandatory use of Plant and Machinery for execution of different items of work as per agreement conditions and standard data and also for adopting RFI and O.K card system.
- 2. Circular instructions were issued from this office vide reference 2<sup>nd</sup> cited to execute works as per MORT&H specifications according to which specified category of Plant & Machinery is mandatory. As per Annexure-I enclosed to the reference 2<sup>nd</sup> cited, Wet Mix Macadam obtained from Pug mill is to be laid/spreaded by Mechanical Paver Finisher 100 TPH.

3.Inspite of issuing above instructions, it has come to the notice of the Engineer-in-Chief(R&B) Administration & Quality Control, Hyderabad that some of the Superintending Engineers and Executive Engineers(R&B) in charge of execution are allowing spreading of Wet Mix Macadam item of work with un-specified machinery like Motor Grader/Tractor Dozer instead of Mechanical Paver as specified.


