Therefore, allowing WMM with un-specified machinery will be viewed seriously and concerned field Engineers will be held responsible and necessary disciplinary action will be initiated against defaulters.

The Executive Engineers are, further, requested to communicate the circular to all the Deputy Executive Engineers and Assistant Executive Engineers/Assistant Engineers under their jurisdiction, to comply with the instructions.
