ORDER:

The Engineer-in-Chief (A.W), Hyderabad in references 1<sup>st</sup> & 2<sup>nd</sup> read above has stated that Government have issuing G.O.Ms.No.94, I& CAD (PW – COD) Department, Dt: 01-07-2003, the Cabinet Sub-Committee had examined the various issues relating to Registration of Contractors including streamlining & simplification of procedure in all the departments in order to achieve better results and made recommendations to the Government for online of Contractors Registrations. The Government have recommended for development of website and directed the Department to develop a website for online Registration of Contractors. The Centre for Good Governance was entrusted the job of development of web portal for online Registration of Contractors, hosting, maintenance and technical assistance during the meeting held on 24-09-2015 by the Commissioner, COT.

2. He has further stated that, the Officials of the Centre for Good Governance (CGG), Hyderabad have given presentation on the Online Registration of Contractors through web portal developed by them to the Board of Chief Engineers, during the 3<sup>rd</sup> BOCE's meeting held on 11-11-2016. The application of web portal includes the process of submission of application, uploading documents, evaluation & verification of documents & submission of application to COT and online approval of the same by the Commissioner, Commissionerate of Tenders, in respect of Special Class & Class-I Contractors. At present the portal has been developed for "Civil Category" only and will be extended for all other categories of Registration in near future. In this regard, the Board of Chief Engineers has discussed in detail in the 3<sup>rd</sup> BOCE's meeting held on 11-11-2016 and agreed in principle for the proposed online Registration of Contractors by launching a web portal for Special Class and Class-I at initial stage and opined that prior permission from the Government may be obtained for taking up the process of online Registration.

3. The Engineer-in-Chief (A.W), Hyderabad has requested the Government to accord permission for the proposed online Registration of Contractors web portal for Special Class and Class-I registrations in the category of "Civil" to all the Engineering Departments of Telangana. He has also stated that, the Centre for Good Governance has submitted the estimated cost for the Design, Development of online Registration of Contractors hosting, maintenance & technical support as detailed below along with the payment terms.

- a. To Develop & implementation of the web portal for online Registration of Contractors for Special Class and Class-I registrations in the category of "Civil" to all the Engineering Departments of Telangana.
- b. Sanction of Estimated amount of Rs.10.00 Lakhs (Ten Lakhs) towards the development of Web Portal for online Registration of Contractors for Special Class & Class-I in the category of "Civil" including Design, Development and maintenance of website for a period of one year and chargeable to the following Head of Account:

"2700 M & MI 80- General 001- Direction & Administration, 11- Normal State Plan.01- Head quarter office common establishment 280/284 - Professional services - other Payments".

6. The Engineer-in-Chief (A.W), Hyderabad shall take further necessary action accordingly.
