Modifying financial limits for QC inspection of works and out-turn / target of
inspections -Certain instructions-Issued-Reg.

(R&B)Department of Telangana State on 23.06.2016

(R&B)Department has taken up large number of works the state of Telangana. After detailed discussion in COCE meeting on 23.06.2016,it is decided to enhance targets for QC inspection for effective functioning and evaluation of quality at all stages of work. The targets & financial limits are revised as below.

Sl.No.	Designation	Value of work to be inspected by QC Engineers Rs.in Crores	Minimum No. of works to be inspected in a month
1	DEE/QC	i) All road works up to Rs.2.00 Crores and issue RIR or QCR report ii) Bridge and Building works up to Rs.1.00 Crore only and issue RIR or QC report. iii) For works costing more than Rs.2.00 Crores, the DEE/QC may inspect the work and issue RIRs only.	20
2	EE/QC	All works up to Rs.10.00 Crores and issue QC report	15
3	SE/QC	All works costing more than up to Rs.10.00 Crores and issue QC report	8

The committee has also decided that rejection of work due to substandard execution recommended by a QC Engineer shall be finalized by the next higher officer in the QC wing after due verification ,before communicating to the filed officers. Whenever abnormal deficiencies are noticed during inspection of a work leading to rejection of a item or certain items of work, QC Engineer(R&B) shall report such abnormality immediately to his next higher officer and that higher officer (QC) shall after due to verification by himself within next 3 days communicate such abnormality/rejection with a copy to Engineer-in-Chief(R&B) Admin. &QC, to the concerned filed Engineers i.e SE & EE (R&B) duly submitting a copy to concerned Head of the Department of the work.

The QC Engineers shall inspect all ongoing works as many as possible duly covering all stages/provisions of work to identify the lapses ,if any to ensure Quality rather than pointing out the lapses after the work is completed.

The instructions shall be followed scrupulously by all QC Engineers and any violation will be viewed seriously.
