- After careful examination of the matter, and keeping in view of the recommendations of the Board of Chief Engineers Government hereby enhance the technical sanction powers for Electrical works, to all the Government Buildings in the State to all the Executive Engineer (Electrical) and Superintending Engineer (Electrical) in the R&B Department from the existing limitations of Rs.1,00,000/- to Rs.5,00,000/- and Rs.5,00,000/- to Rs.15,00,000/- respectively, for smooth and quick action for timely completion of the works and to avoid adverse comments.
- The Engineer-in-Chief(R&B),Admn.,&Q.C, Hyderabad shall take necessary action in the matter accordingly.
