(iv)	Five representatives from directly affected areas, with at least two women, nominated by the Governing Council.	:	Members

(vi)	Asst. Director of Mines & Geology concerned.	:	Member
(vii)	One representative from mining companies contributing to the Trust, nominated by the mining companies operating in such district or association thereof.	:	Member
(viii)	Lead Bank Officer of district, nominated by the Governing Council.	:	Member
(ix)	Serving officer of the Government not lower than the rank of Class I Officer or Additional District Magistrate with experience in disciplines of rural development or social welfare, to be appointed by the Government.	:	Member-Convener
