The instances are brought to the notice of the under signed that the works sanctioned under various grants of State Plan and Non-Plan like MNP, MPO Buildings, RRM and School Buildings are being executed departmentally. Further it is hereby informed that the requested are being received from the Executive Engineers (PR) and Superintending Engineers (PR) for according permission to execute the works sanctioned under State Plan and Non-Plan grants departmentally.

All the Superintending Engineers(PR) and Executive Engineers(PR) are aware that the works sanctioned under State Plan and Non-Plan grants shall be executed duly inviting the tenders as per the departmental procedure, which is the statutory rule of PRED. N powers are delegated to take up the works departmentally.

Further, all the Superintending Engineers(PR) and Executive Engineer(PR) are also aware that now a days the trend of tenders is very competitive and the tenders are also being received at lesser premium, which will cause the savings to the Government funds, Particularly this trend of tenders is more competitive for the works of RRM grant. For the works entrusted on tender basis the amount deducted towards Income Tax, Seigneriorage Charges, turn Over Tax etc., will be the added source of income to Government funds. More over there will be a source of revenue to the Department on purchasing of tender schedules.

As such all the Superintending Engineers(PR) and Executive Engineers (PR) in the State are once again advised not to execute the works sanctioned under State Plan and Non-Plan grants viz MNP, MPO Buildings, RRM and School Buildings on nomination basis or departmentally. They are also requested to follow the above instructions for the works sanctioned under MPLADS grant at district level.

The officers will be held responsible and will be taken to task if any deviations are observed in the implementation of the above instructions. The PAOs are also advised to adhere to the above instructions while clearing the work bills of works sanctioned under the above grants.

The above instructions shall be acknowledged at first instance and all the Superintending Engineers and Executive Engineers are requested to communicate the above instructions to all the field staff.
