Minutes of the Meeting held in the Conference Hall by the Hon'ble Chief Minister to review and approve the welfare and other schemes for the Building and Other Construction Workers on 14.6.2010.

ORDER:

Section 22 of the Andhra Pradesh Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 empowers the Board constituted under the Act to provide welfare measures and facilities to the Building and Other Construction Workers registered as beneficiaries with the Board.

- 2. The Andhra Pradesh Building and Other Construction Workers Welfare Board has resolved to implement certain welfare schemes to cover the beneficiaries registered with the Board. One, among the welfare schemes is the Scheme for Temporary Disability (due to accident / disease) Relief to the Building and Other Construction Workers.
- 3. After examination, the Government hereby approve the scheme of providing Temporary Disability (due to accident / disease) Relief to the Building and Other Construction Workers, who are registered as beneficiaries with the Andhra Pradesh Building and Other Construction Workers Welfare Board with the following guidelines:
 - i) The claimant shall be a registered construction worker of the Board and his/her membership should be live.
 - ii) If the registered Building and Other Construction Worker is hospitalized for 5 (five) or more days due to accident or any disease, he/she is entitled for sanction of this benefit by the Board.
 - iii) The financial assistance shall be @ Rs.100/- per day and maximum of Rs.1500/- per month. If the hospitalization / disability continues due to disease like heart aliments, kidney failure, cancer or any other such terminal disease, on production of a certificate from the Medical Officer concerned, the Board may extend the relief up to 3 months @ Rs.1500/- per month.
 - iv) Medical Certificate issued by the Government Hospital / Primary Health Centre not below the rank of Civil Assistant Surgeon who is providing treatment to the patient, should be the basis for sanctioning this relief.
 - v) If any registered workers is in receipt of any benefit from other welfare and social security scheme, for the same cause, he/she will not be eligible for relief under this scheme except such patients getting treatment of the injuries due to accident / any such disease under the Rajiv Arogyasri Scheme.

- vi) The worker shall submit the application duly filled in with necessary documents and the medical certificate to the local Assistant Labour Officer/Assistant Commissioner of Labour or the Deputy Commissioner of Labour in the district immediately.
- vii) The Application shall be duly enquired by the Assistant Labour Officer/Assistant Commissioner of Labour within (7) days and forwarded to the Deputy Commissioner of Labour for sanction.
- viii) In case, the application is found defective or any documents are missing, the Deputy Commissioner of Labour shall return the same to the Claimant within (7) days by mentioning specific reasons and also advising to resubmit within a week duly rectifying the defects.
- ix) The Deputy Commissioner of Labour concerned will sanction the benefit within a week after receiving the application in full shape with necessary documents and forward the sanction proceedings within (7) days to the Board for release of the amount.
- x) The Board shall release the amount within (7) days directly to the **beneficiary's** bank account and the entire data of the claim application, sanction of relief, payment etc., will be uploaded on the Website of Board.
