In the reference 1<sup>st</sup> cited, the Government issued certain guidelines to be followed by all PR Department Engineers regarding sanction of estimates and execution of works. Further in the reference 2<sup>nd</sup> cited, the Government in PR & RD Department have accorded administrative sanction for utilization of 0.50% Q.C. Charges towards QC Equipment, Survey Instruments, Computers, Softwares and Consumables for PIU Divisions, Sub-Divisions and Circles. It is observed that, the above Govt. Memo and Govt. Order issued by the PR & RD Department involving financial implication do not bear the concurrence of Finance Department. It is noticed that, bills towards purchase of QC Equipments etc., relating to PR & RD Department are being received in the Offices of the PAOs / APAOs.

In this connection, the attention of all the PAOs / APAOs / JDWAs is invited to the U.O. Note No.1942/F3(1)/2006-1, Finance (Works & Projects) Department, dated 15.11.2006 already communicated to JDWAs vide Endt. No.DWA/Hyd/Sn.II/A9/240, dt. 18.11.2006, wherein specific instructions have been issued that, in respect of all sanctions which require concurrence of Finance Department as per rule 37 of AP Govt. Business Rules and Secretariat Instructions should be followed or else any claims on such sanctions shall not be entertained by the PAOs / APAOs for payment. However, a copy of the Govt. Memo is again communicated to all PAOs / APAOs / JDWAs for guidance.

In view of the above, all the PAOs / APAOs are hereby directed to follow the instructions of the Government Memo scrupulously while dealing with such cases. They are
