- (i) Column 9: A temporary Government servant who completes one year's continuous service during the middle of a month shall commence subscribing to the General Provident Fund from his/her salary for the month following that in which he/she completes one year's service.
- (j) The nomination should be obtained in the prescribed form from the subscriber and forwarded to the Accountant-General along with this statement making a suitable note in the remarks column.
