Order:-

In the reference 1<sup>st</sup> cited, Government issued comprehensive instructions relating to simplification of procurement procedure, achieving greater transparency, reducing delay in procurement process etc. In the reference 2<sup>nd</sup> read above, amendment orders were issued to para 12 of Annexure-I to G.O. 1<sup>st</sup> cited with regards to qualification criteria for works. In the reference 3<sup>rd</sup> cited, amendment orders were issued to Annexure -III of G.O. 1<sup>st</sup> cited regarding changes in monetary limits, registration fee, solvency certificate and past experience certificate and other requirements. In the reference 4<sup>th</sup> read above, amendment orders were issued to enlarge the experience gained during the last 10 years for registration instead of limiting the experience to last 5 years only as per G.O.Ms.No.94, I&CAD(PWCOD) Department, dt: 01-07-2003 para 3 in respect of I&CAD Department. In the reference 5<sup>th</sup> cited, amendments were made to Annexure-II para- I (h) of G.O. 1<sup>st</sup> cited in respect of Class of contractors and further modification of monetary limits.

2. After formation of Telangana State, Builders Association of India, Telangana State chapter have represented to Government vide reference 6<sup>th</sup> cited for certain reforms to the present norms of the tendering system duly enhancing the monetary limits of the works for various category of contractors.

3. In the reference 7<sup>th</sup> read above, the Engineer-in-Chief (IW), Hyderabad, for the reasons stated in his letter has sought for modification to G.O.Ms.No.130, I&CAD (PW:REFORMS) Department, dt: 22.05.2007, regarding the monetary limits of past experience of civil category for value of group of works and for value of single work that have been executed in any one year during the last five financial years. He also sought for modification to G.O.Ms.No.142, I&CAD (Reforms) Department, Dt. 20-12-2004 regarding qualification criteria for works.

4. In the reference 8<sup>th</sup> read above, the Engineer-in-Chief (Irrigation), Hyderabad further sought for modification to G.O.Ms.No.14, I&CAD (Reforms) Department, dt: 31-01-2015, regarding the monetary limits of works for different class of contractors.

In order to encourage local entrepreneurship, to enhance transparency and competition in procurement works, the Government after careful consideration of various aspects based on the recommendations of Engineer-in-Chief & Board of Chief Engineers, hereby issue amendments to G.O.Ms.No.130, I&CAD (PW:REFORMS) Department, dt:22.05.2007, G.O.Ms.No. 142, I&CAD (Reforms) Department, Dt. 20-12-2004, G.O.Ms.No.14, I&CAD (Reforms) Department, dt: 31-01-2015 as shown in the Annexure-I, Annexure-II and Annexure-III respectively of this order. These modifications will come in to effect from the date of issue of the orders.

6. The Engineer-in-Chief (Irrigation), Hyderabad shall take further necessary action accordingly. This order issues with the concurrence of Finance Department vide their Dy.No.265/PFS/2015, dt: 12-03-2015.

The qualification criteria at para.10 of as well as modified procedure of collecting EMD in the shape of Bank Guarantee will not be made applicable for the works costing Rs.50 lakhs (ECV) and below. For above works single cover system shall be followed and the EMD shall be submitted along with the completed Tender Schedule.	(i). The qualification criteria at para.10 (A) will not be made applicable for the works costing Rs.1000.00 lakhs (ECV) and below. for Civil works in all State/Central Government Departments, State/Central Government undertakings/ Public sector undertakings/ Corporations.  (ii). However for civil works costing Rs.50.00 lakhs (ECV) and below, collection of EMD only in the shape of D.D. will continue.
