ORDER

In partial modification to the orders issued in the reference 8th read above, and in order to completely avoid delay in payment to beneficiaries under Kalyana Lakshmi & Shadi Mubarak Schemes, Government hereby order that the beneficiaries envisaged in Kalyana Lakshmi & Shadi Mubarak Schemes shall be drawn & disbursed by the RDO who should be responsible for verification of correctness of claim beneficiary through the MRO.

The respective RDO shall issues sanction orders duly indicating the list of the beneficiaries prefer a bill to STO / ATO and the amount will be credited to the PD Account of the RDO. After credit of the amount into PD account the procedure prescribed at III to VII in G.O.Ms.No.100, Finance (TFR) Department, Dt:23.08.2016 shall be scrupulously followed by RDO.

The RDOs shall open and maintain P.D. Account in respect of the above mentioned schemes who shall release the funds instead of the Department at the District level.
