ORDER:

In the reference 5<sup>th</sup> read above, the ENC (AW), Hyderabad has stated that in G.O. 2<sup>nd</sup> Government have accorded permission for development of Web Portal for Online Registration of Contractors for Special Class & Class-I in the category of "Civil" in all Engineering Departments of the State of Telangana. The Centre for Good Governance was entrusted the job of Design and development of Web Portal for online Registration of Contractors including hosting, maintenance and technical support for a period of one year during the meeting held on 24.09.2015 by the Commissioner, COT and also stated that in G.O.3<sup>rd</sup> read above, Government have accorded permission for Design, Development & implementation of the Web Portal for online Registration of Contractors for Special Class and Class-I registrations in the category of "Civil" to all the Engineering Departments of Telangana also sanctioned an amount of Rs.11.80 Lakhs (Eleven Lakhs Eighty Thousand)

2. He has further stated that the Board of Chief Engineer's in it's 1<sup>st</sup> meeting held on 28.02.2018 has discussed the above issue and recommended for immediate implementation of Online Registration of Contractors for Special Class & Class-I registrations in the category of "Civil" by all the Engineering Departments of Telangana through designed Web Portal by CGG after obtaining necessary permission from the Government, and also opined that, "the above online Registration may be extended for the remaining classes / categories in a phased manner".

3. He has also stated that Government in G.O.Ms.No.63, I & CAD (Reforms) Department, dt. 21.06.2018, have amended Para (1) (e) i.e Procedure for Registration, Annexure II (Rules for Registration of Contractors) of the G.O.Ms.No.94, I & CAD (PW-COD) Department, dt. 01.07.2003 for mandatory submission of Registration of Contractor applications through Online Web Portal, for Special Class & Class-I in the category of "Civil" for all the Engineering Departments of Telangana.

4. Accordingly, the CGG has developed Web Portal (<http://contractorregistration.telangana.gov.in>) for online Registration of Contractors for submission of registration applications and same is made live from 01.07.2018 for all the Engineering Departments of Telangana till date. Subsequently the CGG was requested to take up the development work of extending Online facility for Registration of Contractors of Class –II to Class-V in the different categories and development is in progress.

The ENC (AW) has requested the Government to amend Para (1) (e) i.e. Procedure for Registration, Annexure-II (Rules for Registration of Contractors) of G.O.Ms.No.94, I & CAD (PW-COD) Department, dt. 01.07.2003 for implementation and mandatory submission of online application for Registration of Contractor applications through Web Portal, for Class -II to Class-V in the category of "Civil" at the first instance on par with amendment issued for Special Class & Class-I vide G.O.Ms.No.63, I & CAD (Reforms) Dept., dt. 21.06.2018 for all the Engineering Departments of Telangana.

6. Government after careful examination of the matter, hereby amend Para (1) (e) i.e. Procedure for Registration, Annexure-II (Rules for Registration of Contractors) of G.O.Ms.No.94, I & CAD (PW-COD) Department, dt. 01.07.2003 for implementation and mandatory submission of online application for Registration of Contractor applications through Web Portal, for Class -II to Class-V in the category of "Civil" on par with amendment issued for Special Class & Class-I G.O.Ms.No.63, I & CAD (Reforms) Dept., dt. 21.06.2018 for all the Engineering Departments of Telangana.

7. These modifications will come into effect from the date of issue of these orders.

8. The Engineer-in-Chief (A.W), Hyderabad shall take further necessary action accordingly.
