**ORDER:**

In the reference 1<sup>st</sup> read above, the new Land Acquisition Act i.e., Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30 of 2013) has been enacted by the Parliament and published by Government of India in the Gazette of India and the same has been brought into force w.e.f. 1<sup>st</sup> January, 2014 vide reference 2<sup>nd</sup> read above.

**2.** In the reference 3<sup>rd</sup> read above, the District Collector, Ranga Reddy while submitting the proposals for acquisition of lands in Pedda Shapur Village, Shamshabad Mandal, Ranga Reddy District to an extent of Ac.6.00 gts for the purpose of Crossing Railway Station between Umdanagar and Timmapur Stations, has requested the Government to delegate the powers to the Special Deputy Collector, Land Acquisition (Industries), Ranga Reddy & Medak District to perform the duties of the Land Acquisition Officer in the matter as required under new Land Acquisition Act, 2013.

**3.** Government, after careful examination of the issue, hereby observe that, general orders have to be issued delegating the powers to the District Collectors for appointing Revenue Divisional Officers/ Spl.Grade Deputy Collectors/ Spl.Dy.Collectors in their respective jurisdictions as Land Acquisition Officers to perform the functions of the Collector for Land Acquisition under Clause (g) of Section 3 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, as was done earlier vide G.O.Ms.No.477, Revenue (LA) Department, Dt.26.08.2013 under Section 3 (C) of Land Acquisition Act, 1894.



4. Accordingly, Government hereby delegate the powers to the District Collectors for appointment of all Revenue Divisional officers/Special Grade Deputy Collectors/Special Deputy Collectors in their respective jurisdictions as Land Acquisition Officers to perform the functions of the Collector for Land Acquisition under clause (g) of Section 3 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

5. The Chief Commissioner of Land Administration & Special Chief Secretary, Telangana, Hyderabad/all the District Collectors in the State shall take necessary further action in the matter accordingly.
