ORDER:

In the G.O. 1st read above, certain guidelines were issued for laying of Optical Fibre Cables along State properties in which it was stated that in case the Service Provider under takes road cutting in any Urban & Rural areas, the Service Provider shall pay the restoration charges prescribed.

2. The Chief Secretary, Government of Telangana has convened a meeting on 21.07.2015 with the Prl.Secretary, MA&UD Department, Secretary, ITE&C Department, CDMA and representatives of GHMC on finalization of Road cutting charges to be paid by the private companies involved in creating infrastructure for 4G services.

3. During meeting it was felt essential to issue a comprehensive and centralized orders in this regard which would greatly help in reducing the time for implementation of the project.

4. The Government after careful examination of the representations received from the Service Providers and keeping in view the decision taken in the meeting held on 21.07.2015 referred above for laying Optical Fibre Cable along road/ Road margins in Urban & Rural areas in the State of Telangana for 4G communication expansion, hereby fix the following charges which the Service Provider shall be liable to pay to the department concerned for restoration of Road in the Urban areas when resorting to open trenching method. The charges are valid even for roads that belong to agencies like HMDA, TSIIC (IALAs) in Urban Areas.

1	CC Roads	Rs.1844/ Rmt
2	BT Roads	Rs.2275/Rmt
3	Footpath	Rs.799/Rmt
4	Berm / WBM	Rs.285/Rmt

5. The above charges are exclusive of VAT and labour cess. The restoration work will be carried out entirely by the department concerned.

6. The above charges will be in force until further orders.
