The Engineer in Chief (General), I&CAD Department has stated that, the Government has re-Organized I&CAD Department with (19) territorial ENC's/CE's and (9) Head quarter ENC's/CE's. based on this orders, new ENC's/CE's units, Circles, Divisions and Sub Divisions are formed and some circles, divisions under the control of existing CE units and attachment of the same to either the existing other units or to the newly formed units. Hence, requested to allot new DDOs codes and admit the salary bills as per the existing system upto 31/03/2021.

Government after careful examination, hereby ordered that :

1. The Director of Treasury & Accounts/The Director of Works Accounts, Telangana State to admit the bills to draw salaries & Other contingent expenditure up to 31-03-2021 to all categories of employees of the Dept, Both undisturbed and newly created ENC/CE units/Circles/divisions from the same DDO/PAO and same Head of Account under which their salaries were drawn prior to re-organization.
2. The Director, Treasury & Accounts, Telangana State shall assign DDO codes for newly created units and to the changing over units as per the necessity, w.e.f 1-4-2021, which will come into force from 01-04-2021.
3. The Director of Works Accounts, Telangana shall issue instructions to all the PAO's/ APAO's to providing Login ID'S and to map the DDO's as per the requirement in IFMIS w.e.f 1-4-2021 in accordance to the new organization set up and smooth functioning of the department

The Director of Works & Accounts / Director of Treasury & Accounts/Engineer in Chief (General), I&CAD Department, Telangana, Hyderabad are requested to take further action accordingly.
