The attention of the Director of Works Accounts is invited to the reference cited and he is requested to examine the issue and send the remarks on the following points:

1. The posts Senior Accountant, Junior Accountant are constituted as different categories of posts in rule (2) of A.P.Ministerial Service rules and are governed by the provision of APMS Rules, 1998.
2. The posts of Superintendent, Senior Steno and Typists are common categories of posts exist in all the Offices of the Heads of the departments and in their respective subordinate offices.
3. As these posts are common category posts exist in all the O/o HODS and in their respective subordinate offices, these categories of posts in the Directorate of Works Accounts and its subordinate office also governed by A.P.Ministerial Service Rules. Therefore, separate rules are not required for these categories of posts in the Directorate of Works Accounts and its subordinate offices.
4. If the Department wants to make additional qualifications etc., for the posts of Senior Accountant, Junior Accountant for the Directorate of Works Accounts, the department may suggest for suitable amendments to the A.P.Ministerial Service Rules without resorting to issue of separate set of rules, as proposed.
5. In the said proposed draft rules, "direct recruitment" to the post of Senior Accountant was proposed. In this connection, it may be stated that as per the A.P.Ministerial Service Rules, there is no provision for direct recruitment to the post of Senior Assistant/Senior Account. The A.P. Ministerial Service rules were issued based on the recommendations of the One Man Commission. The provisions contained in the relevant rules may have to be followed, as they are statutory in nature.
